Before beginning, we recommend reading through the entire application so you understand where information is requested and can avoid unnecessary repetition.

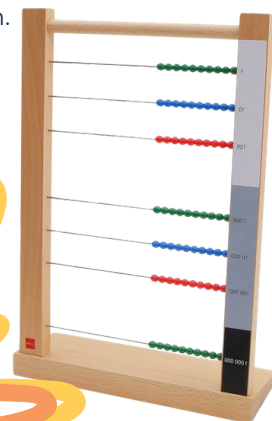
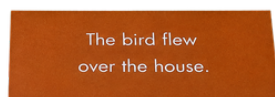
